Here are the directions for **Part 2**. In this part, you will hear six passages, (A) through (F). Each passage will be followed by two questions, **No. 13** through **No. 24**. For each question, you will have 10 seconds to choose the best answer and mark your answer on your answer sheet. The passage and the questions will be given only once. Now let's begin.

★ (A) Burning Iron

Is iron the fuel of the future? According to scientist Jeffrey Bergthorson, iron can be turned into iron powder and then burned to provide clean energy. The process used to produce iron powder requires large amounts of electricity, but it could be done in deserts where sunlight could provide solar power. The iron powder could then be shipped wherever it is needed. Iron powder does not require special modes of transportation or storage facilities. This would be an advantage over fuels such as hydrogen, which can be dangerous to transport.

Bergthorson has shown that his idea is technically possible and would not pollute the air because burning iron produces no CO_2 . He is now working on the next step—building an engine that can actually do the burning. If he is successful, such a device could be used to power large ships or even space rockets.

The Colossus of Rhodes, one of the Seven Wonders of the Ancient World, was an enormous statue of a Greek god. The bronze statue was built about 2,300 years ago in the Greek city of Rhodes to celebrate an important military victory. Many of the other wonders of the ancient world survived for centuries and even millennia, but the Colossus of Rhodes lasted just half a century before it was destroyed in an earthquake.

Today, much is unknown about this huge work of art. For one thing, historians are unsure about its precise location and the details of its appearance. Some ancient documents say the enormous statue stood at the mouth of Rhodes' harbor. Others say the statue was on a hillside overlooking the harbor. Moreover, as with the pyramids in Egypt, no one knows exactly how it was constructed.

Many people start Internet businesses every year. Rather than focusing on immediate profits, they usually concentrate on building their site's popularity among the public. Some businesses do this in the hope they will one day be bought by a huge corporation. Others feel that once they have enough users, they will be able to find a way to make money from their service.

Advertising and subscriptions have traditionally been the most common ways to earn money online. However, one technological development is the use of micro-transactions. Micro-transactions allow users to pay small fees to improve their online experience. For example, a website that offers free car-racing games might offer users the chance to purchase access to a faster car than the ones available to nonpaying customers. In this way, some businesses are managing to survive in a competitive industry.

☆☆ (D) Oldest Stone Tools Discovered

In 2011, a team of archaeologists made an incredible find. While traveling through Kenya's Rift Valley, they took a wrong turn. When the archaeologists climbed a hill to see where they were, they found very simple stone tools that had clearly been shaped by human hands. What is more, the tools turned out to be 2.8 million years old, 700,000 years older than stone tools previously found in Ethiopia, which had been thought to be the world's oldest.

Unfortunately, the site gave few clues about how the tools were used. Clear marks left on animal bones found nearby led some researchers to suggest the tools had been used by local people to remove meat from bones. Others, however, argue that the marks on these bones were simply the result of being stepped on by other animals or being bitten by crocodiles.

★★ (E) Chicago's Problem

In the 1850s, the city of Chicago had a serious problem. It was built in a low-lying area, only a meter or two above the water level of nearby Lake Michigan. Whenever it rained heavily, water levels rose, and the city became a rat- and insect-filled swamp. The streets turned to mud, making travel difficult, and the unhealthy conditions led to outbreaks of disease that killed thousands of citizens.

Chicago officials initially wanted to install drains and pipes under the buildings to carry away the water, but experts thought this wouldn't work. Therefore, the city ordered engineers to move the city's structures using mechanical devices called jackscrews. Even huge hotels weighing thousands of tons were lifted up between one and three meters, and new roads were built on top of the old ones. The project took over 20 years, but it was enormously successful.

☆ (F) College Decisions in the US

Wharton business school professor Peter Cappelli says young Americans must make some tough choices when selecting a college or major. Cappelli says tuition is so costly that students usually take out large loans, which leave them in debt when they graduate. What is more, 40 percent fail to graduate within six years, which has a severe impact on their lifetime earnings. Choosing an affordable college is therefore essential.

Many people select their major at times when jobs in that field are more plentiful. Cappelli, however, advises against this. He says that industries requiring large numbers of employees one year may stop hiring the next year due to economic changes. Cappelli recommends freshmen choose a major they are personally interested in, and that they also select a college based on cost and graduation rates.

After you hear the passage, you will have 10 seconds to choose the best answer and mark your answer on your answer sheet. The passage will be given only once. Now let's begin.

(G) You have 10 seconds to read the situation and Question No. 25.

★It's possible to order from our website and have the book delivered to your home. If you don't want to pay delivery costs, you can ask our staff at the Customer Service Desk to order one for you. They will then fill out a request form for you and notify you once the book arrives, so they'll need a number where you can easily be reached. If we already have the book in our central warehouse, you should be able to pick it up in a day or two. Otherwise, it's likely to take a week.

The most likely explanation is that someone got your password by hacking into your computer. If that's the case, we'll have to report it to the authorities later. For now, however, I have blocked access to your account and stopped all withdrawals. So, the next step is for you to come in within the next few days to open a new account during business hours. Once that's done, we can transfer money from the existing account to the newly created one. Remember, the best way to prevent this from happening again is to change your password regularly.

★You were driving 66 miles per hour in a 55-mile-per-hour zone. The fine is \$200. OK, you can reduce your fine by 50 percent if you complete a free traffic-safety course. You can do that online—this booklet has more information about that. Regardless of whether you complete the course or not, you can pay

\bigstar (J) You have 10 seconds to read the situation and Question No. 28.

 $^{\lower \times}$ Normally, landlords require a credit report to check your credit history. But you haven't used a credit card here, so you don't have one. A letter of reference from your last rental accommodation is a good alternative, but since you own your home in Japan, that won't work, either. I think your best option is to show them you have enough money saved in the bank to cover rent for several months. If that's not enough, you could then have your current employer write a letter stating that you're working with them full time.

\gtrsim (K) You have 10 seconds to read the situation and Question **No. 29**.

 \bigstar I'm most concerned about your dizziness. You don't have a fever, so we can rule that out as the cause. It may be that you're having a reaction to the cholesterol medication I prescribed for you last month. Let's lower the dose to see if that helps. Try taking the tablets once a day instead of twice. If there's no improvement, we'll take you off them for a while. Of course, there are a number of other things that could be causing your symptoms. If it turns out not to be the medicine, we can look into inner-ear trouble and also run some blood tests.
